Day 1 | Monday, September 9, 2024

10:30 AM | A Conversation with Chief Judge Abby Abinanti, Yurok Tribal Court *Abby Abinanti, Yurok Tribal Court*

Join us for a keynote session with the Honorable Chief Judge Abby Abinanti, a trailblazing figure in Tribal justice. As the first Native American woman admitted to the State Bar of California and a citizen of the Yurok Tribe, Judge Abby has dedicated her career to advancing Tribal Courts. After serving on the San Francisco Superior Court, she returned to her roots to transform the Yurok Tribal Court into a model of culturally responsive justice.

Judge Abby will share her views on restorative justice and the strengths and impacts of the Yurok Tribal Court being rooted in the culture values of fairness and responsibility.

9:05 AM | Introduction to Healthy Outcomes from Positive Childhood Experiences (HOPE)

Eliza Posner, Alaska Children's Trust

Positive Childhood Experiences (PCEs) can mitigate the impact of Adverse Childhood Experiences (ACEs) and help children and youth grow into more resilient, healthier adults. Introduction to Healthy Outcomes from Positive Experiences (HOPE) helps child-serving and family-serving providers identify ways they can build these crucial positive experiences and ensure all families have the support they need to grow their strengths.

In this session, participants will explore the research on ACEs and PCEs and think through how they can incorporate the HOPE framework into their work.

3:30 PM | For the Love of Our Children: Re-Centering Indigenous Relational Knowledge

Jessica Ullrich, Washington State University

In this session, Jessica Ullrich will share what has been learned through research efforts involving the development of an Indigenous Connectedness Framework and the application of it to intervention development, language revitalization work, and child welfare/education systems change. All communities have their own sacred knowledge to harness and implement in exponentially powerful ways.

Day 3 | Wednesday, September 11, 2024

9:05 AM | The Alaska Inter-Tribal Working Group and Violence Against Women Act Reauthorization of 2022

This session will explore the changes brought about by the Violence Against Women Act Reauthorization Act of 2022 (VAWA 2022) regarding Tribal jurisdiction in Alaska. Participants will gain insights into the expansion of Tribal jurisdiction under VAWA 2022, the newly established Alaska Pilot Program, and the role and function of the Alaska Inter-Tribal Technical Assistance Working Group (ITWG).

1:30 PM | Domestic Violence, Tribal Child Welfare, and the ICWA: Challenges and Opportunities

Tamra (Tami) Truett Jerue, Alaska Native Women's Resource Center

This session will explore the intersection of domestic violence and the child welfare system. Participants will gain insights into the multifaceted impacts of domestic violence on children and families and examine how the Indian Child Welfare Act (ICWA) can serve as both a protective tool and, at times, an unintended barrier.







Honorable Chief Judge Abby Abinanti | Yurok Tribal Court

Born in San Francisco and raised in Humboldt County, Abby Abinanti, affectionately known as "Judge Abby" in Indian Country, is a citizen of the Yurok Tribe. She is also the first Native American woman admitted to the State Bar of California and the first California Tribal citizen to serve as a judicial officer of the state.

After serving as a San Francisco Superior Court Judge in the Unified Family Court, Judge Abby dedicated her expertise to building the Yurok Tribal Court into one of the most advanced tribal justice systems in the United States.

Departing from the traditional adversarial model, she created a restorative justice system that replaced individual rights with the Yurok Tribe's values of collective responsibility to and for the community as a whole. Judge Abby's vision transformed a system that perpetuated a cycle of poverty and punishment into an expression of who the Yurok people were before they were given the name Yurok. She helped to reclaim their identities as fishermen, basket weavers, storytellers, dancers, healers, medicine people – the 'O'loolekweesh 'o'l.

Her contributions to tribal justice perfectly embody the theme of our conference, "Strengthening Our Roots, Honoring Our Children: Implementing Culturally Responsive Practices for Tribal Justice and Tribal Child Welfare." We are honored to have Judge Abby share her wisdom and expertise at this year's conference.



Alex Cleghorn | *Alaska Native Justice Center*

Alex Cleghorn is the Chief Operating Officer of the Alaska Native Justice Center, where he champions justice initiatives for Alaska Native communities. He has devoted his 20 years of legal practice to representing Native people, Tribes, and Tribal Organizations. In particular, he has served as General Counsel for Southcentral Foundation, Assistant Attorney General and a Special Assistant to the Alaska Attorney General.

Of Sugpiaq descent, Alex is a tribal citizen of Tangirnaq Native Village and a shareholder of Natives of Kodiak, Koniag Incorporated and Cook Inlet Region Inc. He is also a Director of Koniag Corporation and presides as President of the Woody Island Tribal Council, the governing body of the Tangirnaq Native Village. Based in Anchorage, Alex balances his professional life with his role as a husband and father.



Aaron Leggett | *Native Village of Eklutna*

Aaron Leggett has served as the President of the Native Village of Eklutna since January 2018. He also serves as Senior Curator of Alaska History and Indigenous Cultures at the Anchorage Museum and advises the Smithsonian's Arctic Studies Center. He sits on several boards and committees, including the Alaska State Museum Collections committee and the Alaska Historical Society.

Drawing from his Dena'ina heritage and anthropology degree from UAA, Aaron has significantly contributed to indigenous curation in Alaska, authoring scholarly articles and co-authoring publications on Dena'ina language and culture.



Gloria O'Neill | Cook Inlet Tribal Council

Serving as President and Chief Executive Officer for Cook Inlet Tribal Council (CITC) since 1998, Gloria O'Neill has led the organization's growth in becoming one of the most effective service providers in Alaska and the nation.

CITC provides more than 50 essential programs serving more than 12,500 Alaska Native and American Indian people each year. Through rigorous attention to community-based results, Ms. O'Neill has established CITC's national reputation as a leading innovator of replicable and effective service models for culturally informed education, workforce development, family preservation, and substance dependency.

Through its for-profit subsidiary, CITC Enterprises Inc. (CEI), CITC has established an innovative model of sustainability, breaking new ground in social enterprise and impact investing. Under Ms. O'Neill's leadership, CEI launched the first-of-its-kind puzzle-platform video game, "Never Alone (Kisima Innitchuna)" with global acclaim.

Ms. O'Neill served on the University of Alaska Board of Regents from 2012 – 2020 and is a director for the ANJC board. She also serves at the federal level on the Alyce Spotted Bear and Walter Soboleff Commission on Native Children.

Ms. O'Neill earned her Master of Business Administration degree from Alaska Pacific University and received her Bachelor of Arts in Sociology, with a minor in Business Administration, from the University of Alaska Anchorage.

Originally from Soldotna, Ms. O'Neill is of Yup'ik, Sámi and Irish descent.





Eliza Posner | Alaska Children's Trust

Eliza Posner is the Director of Strategy at the Alaska Children's Trust. She received her Bachelor of Arts in Political Science from Northwestern University in 2021. At ACT, she helps lead strategic initiatives focused on the primary prevention of child abuse and neglect.



Toni Bermudez | Cook Inlet Tribal Council

Toni Bermudez is Koyukon and Deg Xinag Athabaskan from HolyCross, Anvik and Galena. She has resided in Anchorage since 1994, was in active addiction for 20 years, and currently has been in recovery for 9 years. She works as a professional in recovery services helping anyone who is facing addiction to walk beside them and with them to find a place to start the healing process. Her message is that anyone who is in the grips of addiction can find a way out into the light.



Samantha Morgan | Cook Inlet Tribal Council

Samantha is a mother in long-term sobriety. She has four children and has been involved with OCS numerous times. She is blessed to share her experience, strength, and hope with families.



Ronald Shugak | Cook Inlet Tribal Council

Ronald has been employed with CITC since December 2022 and has used his personal experience in addiction and recovery to further help participants who are struggling and/or looking into getting into treatment. To Ronald, being a peer means being able to reach someone in there most vulnerable state and having the ability to empathize with the participant.



Amy Urbach | Cook Inlet Tribal Council

Amy is a mother of three adult children and a pet mom. Her career consists of meeting people where they're at, encouraging recovery, supporting the journey, and teaching others. She is currently in the BSW program at UAA and an advocate and friend to those struggling with substance use and mental health issues. As a person in long term recovery, she strives to be the person she needed most when she started her own journey.





Jessica Ullrich | Washington State University

Jessica Saniguq Ullrich is a mom, Tribal citizen of Nome Eskimo Community, descendant of the Native Village of Wales, and an Assistant Professor at Washington State University in the IREACH program. Dr. Ullrich previously worked in child welfare in Alaska, and her passion is to help promote the health and wellbeing of Indigenous children, families, communities, past/future generations, and the Earth.



Tamra (Tami) Truett Jerue | *Alaska Native Women's Resource Center*

As Executive Director of the Alaska Native Women's Resource Center (AKNWRC), Tami Truett Jerue brought 40+ years of direct services experience to this journey, beginning with the formation of AKNWRC in 2016.

Ms. Jerue has testified before Congress and the United Nations, bringing attention to the disproportionate rates of violence experienced by Alaska Native women and the lack of resources faced by tribes. Under her management, the AKNWRC has become a voice for Alaska Native issues, particularly affecting women, children and families, telling truths to promote understanding, building partnerships, and most importantly, supporting Alaska Native tribes as they tackle the complex issues of interpersonal violence.

Ms. Jerue has a Bachelor's degree in Social Work and Master's work in Community Psychology. She worked for the Anvik Tribal Council in Tribal Administration, Indian Child Protection, Domestic Violence/Sexual Assault (DV/SA) and Counseling/Advocacy.




Conference Center Map


