VAWA 2022 Alaska Pilot Program

In October 2023, the Department of Justice (DOJ) announced the launch of a pilot program under the Violence Against Women Act Reauthorization Act of 2022 (VAWA 2022) that will enable Alaska Tribes designated by the Attorney General to exercise special Tribal criminal jurisdiction (STCJ) over non-Indian offenders for certain crimes, including crimes of sexual and domestic violence, that occur in the Village of the participating Tribe. DOJ has outlined three tracks for interested tribes:

Track One

OVW Tribal Affairs Division



All Alaska Tribes interested in exploring the possibility of exercising special Tribal criminal jurisdiction (STCJ), whether they deem themselves ready to immediately exercise STCJ or not, may submit a Preliminary Statement of Interest in joining the Alaska Inter-Tribal Technical Assistance Working Group on STCJ (Alaska ITWG). Tribes may join as part of an intertribal partnership if they so choose. Participants in the Alaska ITWG may or may not ultimately choose to pursue Attorney General designation.

Preliminary statements of interest should be addressed to the Office of Tribal Justice or they may be submitted via email to: VAWA.AlaskaPilot@usdoj.gov. The letter expressing preliminary interest should identify the name and title of any person the Tribe authorizes as its point of contact. This person should be a Tribal officer, employee, or contractor who has been designated by the Tribe's elected officers to act on their behalf. A Tribe may choose to authorize more than one person.

Track Two

Tribes that wish to engage in additional capacity-building activities with the goal of requesting designation as a participating Tribe to exercise special Tribal Criminal Jurisdiction (STCJ) should complete the <u>Statutory</u> <u>Requirements for Exercising Special Tribal Criminal Jurisdiction over Non-Indians questionnaire</u>. The questions in this questionnaire line up with the statutory requirements for exercising STCJ under the Alaska Pilot Program. Tribes should answer "No" for areas where they do not yet have laws, policies, or procedures in place and provide relevant legal materials for areas where they do.

An assigned Federal Project Liaison will work with the Tribe and the Alaska ITWG Technical Assistance (TA) Provider, using the **questionnaire** to identify any unmet requirements and training or technical assistance needs and to develop a Readiness Plan. The Readiness Plan also will identify funding needs and propose avenues for identifying funding sources, including, but not limited to, Department of Justice grant programs.

Tribes that engage in Track Two will be known as Preliminary Pilot Program Tribes. There will be no limit on the number of Preliminary Pilot Program Tribes. Alaska ITWG membership is not required to participate in this Track, but it is encouraged as a source of additional peer-to-peer support.

Track Three

OVW Tribal Affairs Division



Tribes interested in requesting designation to exercise special Tribal criminal jurisdiction (STCJ) as Participating Pilot Program Tribes must submit a *Request for Designation*, with a completed Statutory Requirements for Exercising Special Tribal Criminal Jurisdiction over Non-Indians *questionnaire*, certified by Tribal leadership. Tribes may submit jointly for designation as an "intertribal partnership" and should include signed certifications from each Tribe.

Tribes seeking designation do not need to previously have been Preliminary Pilot Program Tribes.

Next Steps: Department of Justice staff with expertise regarding STCJ will review the completed **questionnaire** and recommend either:

- a) Attorney General designation as a Participating Pilot Program Tribe,
- b) maintaining the Tribe's status as a Preliminary Pilot Program Tribe (if applicable), or
- c) inviting the Tribe to become a Preliminary Pilot Program Tribe.

If either **(b)** or **(c)** is recommended, the Federal Project Liaison will partner with the Tribe and the technical assistance provider to create either an updated or initial Readiness Plan.

A request for designation should take the form of a short letter from the Tribe's leader or governing body addressed to:

Requests for designation may be submitted via email to VAWA.AlaskaPilot@usdoj.gov. The letter requesting designation also should identify the name and title of any person the Tribe authorizes as its point of contact. This person should be a Tribal officer, employee, or contractor who has been designated by the Tribe's elected officers to act on their behalf. A Tribe may choose to authorize more than one person.
